# Series Synopsis

A family on holiday is arrested and accused of killing a local resident.

Their home back in the United States in raided and tons of evidence has been found, plotting the murder of this man.

Through a series of investigations and interviews, the series will take on the issues of right and wrong in the justice system and come to eventually conclusion - were the family framed?

At the end of the series, they have escaped imprisonment and are free, but in the last few scenes, it is revealed that the family planned the murder and are not innocent.

They change their identities and vanish from all who knew them.

#### Episode One Overview

The Peters, an English family, are on holiday in Spain enjoying the sun on the beach when the body of Frank Marts is washed ashore nearby. The beach is closed. Frank Marts property is searched, and a diary is discovered linking him to the family.

The family are arrested and separately interviewed by the Spanish authorities. They plead their innocence about not knowing the man. They believe they are being framed.

At the end of the episode, an English lawyer arrives, who seems to know more about the case than he lets the family know.

# Visual Realisation / Important Images

Sunny/rainy Spain. Interview rooms. The beach. Police station. Spanish towns. Car chases. Flashbacks. Jail cells. Hidden messages and notes used by the family to communicate when they are separated from one another.

#### Statement of Intent

With the endless possibilities of a crime story whereby the main questions are whether the family are innocent or not, this story will take a new route questioning their loyalties to one another, and as to how they are all connected to case. The story centres around an ordinary family plunged into an extraordinary circumstance and makes the audience question what if that was them? What if there was compelling evidence to convict them to a crime?

Audiences looking for a fast-paced crime thriller with lots of twists and turns with an unexpected ending then Vanish is for them. Six episodes of high-octane thrills, audiences who enjoy binge watching will likely be the ones to enjoy this from start to end in one sitting.
